


1. In accordance with Clause A.18 – 52.217-9 Option to Extend the Term of the Contract (MAR 2000) Option Periods Seven and Eight are hereby exercised. The period of performance for Option Periods Seven and Eight is May 12, 2015 – November 11, 2015.
2. Clause A.2 – Consideration and Obligation is modified to read as follows:
