This letter is to inform you of my opposition to the construction of the two proposed Nuclear Power Reactors - 6 & 7- at Florida Power and Light's Turkey Point facility.

I will not bore you with tales about the dangers of nuclear accidents. Those are already well known. The cooling canals at the current Turkey Point facility do not function properly for the existing site. Scarce water from the South Florida Acquifer must now be drawn to cool the reactors properly. The size of these canals are already a blight on our sensitive Florida landscape and the drawing down of water for cooling purposes endangers our drinking water supply.

Let's talk cost. Before billions are spent to build new reactors way far south of the points of use and the transmission lines to carry that power north, we must <u>demand</u> that Florida Power and Light investigate solar panels on all large flat roofs in the urban areas to produce power at the point of use and negate the need for both the reactors and transmission lines to get the power where it is needed. I contend the cost will be levels of magnitude LESS than two nuclear reactors.

Building any such plants on the shores of Florida, which will see the sea rise up to 10 feet in 50 years, is lunacy.

Florida is the "Sunshine State". We need to use the resources that nature provides us here to save money and save our environment at the same time.

I ask you to consider the consequences and alternative to any decision.
