The following additional information is needed to complete the review of your request to remove 10 CFR 35.300 materials from your NRC license.

1. Please state the kinds and quantities of 35.300 materials you possessed, used and stored. For example, we only used Iodine-131 in millicurie quantities (30 millicuries maximum) for hyperthyroid treatments.
2. Please state the final disposition of any 35.300 materials waste. For example, radioactive waste was returned to the radiopharmacy for disposal. Any contaminated paper items were decayed to background radiation levels and disposed of as "normal" trash.
3. Please submit an evaluation (surveys) of areas where 35.300 materials were possessed, used or stored.
4. If you performed close-out radiation surveys using a g-m meter and wipe tests, please submit:
 - a. a facility diagram indicating where the surveys were performed. Indicate where radiation levels were measured and where wipe tests were taken.
 - b. the make and model of the survey instrument and the instrument used to analyze the wipe tests.
 - c. the date the g-m survey meter was last calibrated.
 - d. the identity of the person who performed the survey.
 - e. the background radiation levels for the g-m surveys and wipe tests.
 - f. the date of the survey.
5. Since the license will no longer be authorized for 35.300 materials, we will remove the authorization for 35.300 materials from Dr. Thomas Bowers authorization. Please acknowledge.
