NOTICE

(Pursuant to 10 C.F.R. § 2.309(j))

On November 12, 2014, Entergy Nuclear Operations, Inc. filed a license amendment request (“LAR”) for Palisades Nuclear Power Plant.<sup>1</sup> On March 9, 2015, Beyond Nuclear, Don’t Waste Michigan, Michigan Safe Energy Future – Shoreline Chapter, and the Nuclear Energy Information Service (collectively “Petitioners”) submitted a petition to intervene and request for a hearing to challenge the LAR.<sup>2</sup> Entergy and the NRC Staff filed answers opposing the petition,<sup>3</sup> and Petitioners filed a reply on April 10, 2015.<sup>4</sup>
