This refers to your application dated April 1, 2015, for renewal of your NRC license. Enclosed with this letter is the renewed license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

Your application (NRC Form 313) that you sent via e-mail also indicated that you sent a check for \$2000 for renewal of your license. Please note that there is no fee for renewal of license. However, each licensee is required to pay an annual fee. Please contact Kelly Riner at (301) 415 6246 or Lynn Bates at (301) 415 5092 regarding all matters related to fees and how and where to send these payments.

Please be reminded of the NRC policy that all correspondence related to NRC license must be signed by a member of the licensee's senior management, rather than the Radiation Safety Office or a consultant. Your adherence to this requirement will assist us in processing your correspondence in a timely manner.

The NRC expects licensees to conduct their programs with meticulous attention to detail and high standards of safety and compliance. Serious consequences to employees and the public can result from failure to comply with NRC requirements, therefore you must conduct your program according to NRC regulations, the conditions of your NRC license, and the representations made in your application. You must notify the NRC in writing if:

1. Your mailing address changes;
2. You decide to permanently cease the activities authorized by the license;
3. You decide to acquire licensed material in excess of the possession limits specified on the license;
4. You change the Radiation Safety Officer named on the license;
5. You change the name or ownership of your organization.

The NRC will continue to periodically inspect the conduct of your licensed activities to verify that the activities are conducted in full compliance with the regulatory requirements. Failure to conduct your program safely and in accordance with NRC regulations, license conditions, and the representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, imposition of a civil penalty, or an order suspending, modifying or revoking your license.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
