MEMORANDUM AND ORDER
(Order Fixing a Date for Filing)

The Staff of the Nuclear Regulatory Commission has requested, in its "Motion for Scheduling Order," June 3, 1998, that NDT Services, Inc., be required to file a new answer and stay request no later than July 1, 1998.

We are aware that NDT Services, Inc., whose license is suspended, may be having difficulty retaining a lawyer and preparing a response that complies with 10 C.F.R. § 2.202. Nevertheless, the deadline requested by the Staff seems fair. In the absence of a response to the Staff Motion from NDT Services, Inc., we have decided to establish the requested deadline of July 1, 1998. That deadline may be altered only by a written filing in which good cause for a further delay is demonstrated. NDT Services, Inc., is encouraged to file its response or a request for an extension promptly, preferably prior to July 1,


