The U.S. Nuclear Regulatory Commission (NRC) conducted a security inspection on April 27 - 30, 2015, at your PULSTAR Nuclear Reactor Facility. The inspection included a review of activities authorized for your facility. The enclosed report presents the results of that inspection.

The inspection examined activities conducted under your license as they relate to security and compliance with NRC rules and regulations, and compliance with the conditions of your license. The inspector reviewed selected procedures and records, observed activities, and interviewed personnel. Based on the results of this inspection, no findings of significance or non-compliance with NRC requirements were identified. No response to this letter is required.
