Our other Connecticut gauge remains located at the New Haven location listed on the license.



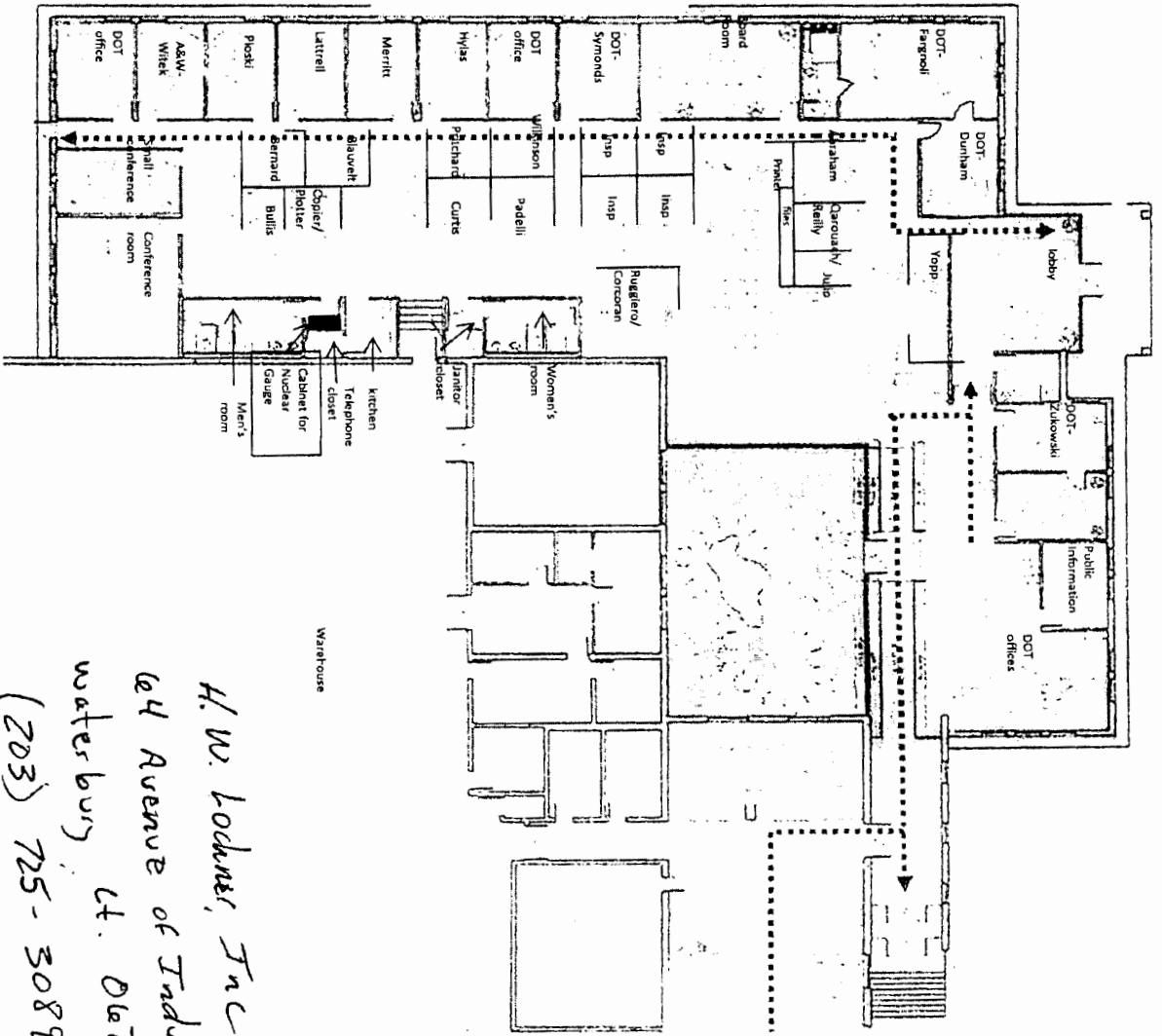
