**SUBJECT: NRC INSPECTION REPORT NO. 03030657/2015002, TESTING TECHNOLOGIES, INC., WOODBRIDGE, VIRGINIA SITE AND THE DULLES AIRPORT, DULLES, VIRGINIA, AND NOTICE OF VIOLATION**

Dear Ms. Case:

On April 20 and 21, 2015, Dennis Lawyer of this office conducted a safety inspection at the above address and at the Dulles Airport, Dulles, Virginia of activities authorized your NRC license. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. Additional information provided in the telephone conversation on May 7, with Gary Kolbenstetter of your organization and on May 8 with you and this office was also examined as part of the inspection. The findings of the inspection were discussed with you at the conclusion of the inspection.

Based on the results of this inspection, the NRC determined that a Severity Level IV violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation is cited in the Notice of Violation (Notice), provided as Enclosure 1 to this letter. The violation is cited because it was identified by NRC. Enclosure 2 provides a determination of severity level and a description of the corrective actions taken by Testing Technologies, Inc., to address the violation.

The NRC has concluded that information regarding the reason for the violation, the corrective actions taken and planned to correct the violation and prevent recurrence is already adequately addressed in our records. Therefore, you are not required to respond to this letter unless the description of your corrective actions in Enclosure 2 does not accurately reflect your actions or your position. In that case, or if you choose to provide additional information, you should follow the instructions specified in the enclosed Notice.
