The purpose of this letter, pursuant to 10 CFR 70.32(e), is to provide the NRC with a revision made to the HDP Physical Security Plan approved by Reference 1 as revised by Reference 2 that does not decrease the effectiveness of the Physical Security Plan.

The revision to the HDP Physical Security Plan incorporates a minor change to the Controlled Access Area boundary fence as approved in Reference 1 and also addresses the use of turnstiles.

Provided in Attachment 1 are the revised pages to the HDP Physical Security Plan dated September 11, 2013, as a track change version for ease of reviewing the plan; Attachment 2 are the revised pages to the HDP Physical Security Plan dated September 11, 2013, as a clean version.
