ORDER

On July 3, 1996, the Nuclear Regulatory Commission received a Request for Extension of Time from Innovation Weaponry, Inc. ("the licensee") to file the bases for its contentions in this matter until September 20, 1996. This is the second such request by the licensee. As with the previous request, the NRC staff did not oppose the extension provided that the licensee agreed in its submittal to remain in compliance with the May 15, 1996 Confirmatory Order. In its motion for this extension, the licensee reiterated its agreement to so comply.

Therefore, under the authority given me by 10 CFR 2.772, I hereby extend to September 20, 1996, the time in which the licensee must comply with the Commission's June 26, 1996 Order. Any answer the NRC staff chooses to file remains due 15 days after the licensee's submittal.


