This letter is to request information to support the Emergency Action Level and Emergency Plan change inspection that will be conducted during the third quarter of 2015. This inspection will be performed as an in-office review and in accordance with the U.S. Nuclear Regulatory Commission (NRC) baseline inspection procedure IP 71114.04.

In the past, this inspection was conducted at the end of the calendar year, and all requests were made informally to your staff. However, in order to increase efficiency and timeliness of the review, and promote consistency of document requests across the sites, this request is being sent to all operating reactor licensees in Region III.

The list of requested documents needed for this inspection from each site is enclosed. We are requesting that these documents are for the time period specified in the list, as applicable.
