I am replying to your email to the Chairman of the U.S. Nuclear Regulatory Commission (NRC), Stephen Burns, dated May 25, 2015 (attached). You stated that you have been researching the NRC public website, specifically <http://www.nrc.gov/info-finder/decommissioning/complex/iluka-resources.html>, for attorneys and legal resources and asked if someone is available to answer a few questions that you have regarding legal and bankruptcy issues. The link that you provided is for the webpage that contains a brief description of the Iluka Resources, Inc. complex decommissioning site in Green Cove Springs, Florida. The State of Florida is an Agreement State, which means that Florida has assumed regulatory authority over certain nuclear materials under the Atomic Energy Act of 1954, as amended. Specifically, Florida has regulatory oversight over the Iluka Resources, Inc. site, not the NRC. Therefore, please direct any specific questions that you have regarding this site to the Florida Department of Health.
