SUBJECT: SUMMARY OF A PUBLIC MEETING ON MAY 27, 2015, WITH
MEMBERS OF THE AP1000 DESIGN CENTER TO DISCUSS THE
LEVY COMBINED LICENSE APPLICATION DEPARTURE
ADDRESSING CONTAINMENT CONDENSATE RETURN DESIGN

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting on May 27, 2015, at 2:00 p.m. with members of the AP1000 design center. The purpose of the meeting was to discuss AP1000 combined license (COL) issues, focusing on the Levy COL departure request addressing a change to the containment condensate return design as described in a May 5, 2015, supplement to the departure request submitted by Duke Energy Florida (DEF).¹ The list of attendees is enclosed. The meeting notice is available in the Agencywide Documents Access and Management System (ADAMS).² The meeting notice is also posted on the NRC public website.³

The meeting included an open session during which the staff requested clarification on issues related to the above mentioned May 5, 2015, submittal, identified in advance of the teleconference, as follows:⁴

- Duke and Westinghouse confirmed that the markups of the AP1000 design control document and the final safety analysis report appearing in Enclosures 2, 3, and 8 included in the May 5, 2015, submittal represented additional changes related to the condensate return departure, over and above the changes included in 2014 submittals and in their 2014 COLA update. In response to a staff request, Duke and Westinghouse agreed to provide the staff with a reviewer's aide of a design control document (DCD) redline/strikeout that included all DCD changes being requested under the condensate return departure.
