The Maximum Ordering Limitation Clauses is hereby revised as follows:

The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this agreement during the five year period of performance is \$8,189,741.00. The Contracting Officer may place orders with the DOE Laboratory during the agreement period provided the aggregate amount of such orders does not exceed the MOL.

Funding will be obligated on the awarded Task Order's issued off this Task Ordering Agreement (TOA). Task ordering procedures are found in section 4.1 in the Statement of Work entitled "Procedures for Placing Task Orders Under this TOA".

All other terms and conditions remain unchanged.

This agreement is entered into pursuant to the authority of the Energy Reorganization Act of 1974, as amended (42 U.S.C 5801 et seq.). This work will be performed in accordance with the NRC/DOE Memorandum of Understanding dated November 24, 1998. To the best of our knowledge, the work requested will not place the DOE and its contractor in direct competition with the domestic private sector.
