Subject: Westinghouse Request for Technical Review and Audit Meeting on the Specialized Seismic Option Program

Dear Mr. Burkhart,

Westinghouse requests a Specialized Seismic Option Technical Review and Audit Meeting with the NRC staff. The purpose of this meeting is to provide an opportunity for the NRC staff to conduct a pre-submittal review/audit of the technical information supporting the Specialized Seismic Option Report in anticipation of an acceptance review for the Option Report to be submitted in September.

It is anticipated that this meeting will start with a brief public presentation on the Specialized Seismic Option current status and meeting objectives. Afterwards, the meeting will be closed to the public and contain a short proprietary presentation relaying an overview of the technical calculations provided and a roadmap on how the calculation fit together. Following this, the subject matter experts for the calculations will be available to answer any questions regarding the audit of the calculations.

The technical calculations for the Specialized Seismic Option will be made available in the Westinghouse Rockville office, on June 15, 2015 unless otherwise specified, approximately two weeks prior to the proposed meeting date and copies will be maintained in the Westinghouse office until the end of July. A proposed agenda is attached. A complete list of the calculations to be available in the Rockville office is provided in the proprietary presentation being provided for this meeting.

Westinghouse requests that the meeting be conducted sometime between June 29, 2015 and July 10, 2015 with target dates of June 30 and July 1, 2015. To facilitate the Technical Review and Audit, Westinghouse would like to host the meeting at the Westinghouse Office in Rockville, Maryland.

Draft presentations for the open and closed portions of the meeting will be provided in a separate transmittal. The closed presentation package will contain a list of the calculations which will be provided.
