We have an affirmation session today with two items before us.

Doctor Bates?

DR. BATES: Mr. Chairman, the first item is SECY-94-196. It's the Final Rule Amending Part 110 Concerning Exports of Alpha-Emitting Radionuclides, Tritium and Transuranic Isotopes.

The Commission is being asked to approve a final rule amending the export regulations in 10 CFR Part 110 to: number one, conform them to export control guidelines of the international Nuclear Suppliers Group with respect to tritium and certain specified alpha-emitting nuclides; two confirm them to the controls of the Coordinating Committee for Multilateral Export Controls for exports of several transuranic isotopes; three, adjust annual limits on exports of Canadian-origin uranium to conform to the U.S.-Canada Agreement for Cooperation; and, four, revise the language in Appendix A of Part 110 to describe more precisely the reactor components subject to NRC export licensing jurisdiction.

All Commissioners have approved the amendments to the Part 110 as final.

5 DR. BATES: The second item is SECY-94-216. It's  
6 the Final Rulemaking on the new 10 CFR Part 76 Certification  
7 of the Gaseous Diffusion Plants.

8 The Commission is being asked to approve a new  
9 regulation for the certification of the two uranium  
10 enrichment gaseous diffusion plants operated by the U.S.  
11 Enrichment Corporation.

12 All Commissioners have approved the new regulation  
13 in 10 CFR Part 76 as proposed in the SECY paper and with  
14 clarifications that were proposed by the Chairman,  
15 Commissioner Rogers and Commissioner de Planque.

16 Will you affirm your votes, please?

17 CHAIRMAN SELIN: Aye.

18 COMMISSIONER ROGERS: Aye.

19 COMMISSIONER de PLANQUE: Aye.

20 CHAIRMAN SELIN: Okay.

21 DR. BATES: That's all I have.

22 CHAIRMAN SELIN: Thank you very much.
