Purpose of Meeting: This is a meeting between the U.S. Nuclear Regulatory Commission (NRC) and Exelon Generation Company, LLC, to discuss the significance associated with an apparent violation of design control requirements resulting in an associated violation of the technical specifications to the station's license for a system being inoperable for a period longer than the technical specification allowed outage time. The apparent violation is discussed in NRC Inspection Report 05000461/2015001 (ML15134A224), and the issue appears to be of low to moderate safety significance, i.e., White.
