Discussion: I called Mr. Lucas about some questions associated with his new application. I asked about the general licensed material and he stated that he listed them but they would not be part of the specific license. I will include this as a confirmation on the electronic mail request to him. I asked if he plans to transfer the portable gauge and he said that he did plan that. I asked about the sources in storage and he said that they were spare gauges to be used later and not for disposal. I asked when he needed the license and he wanted to use it on July 1st when The Chemours Company takes over the site. I asked about the authorized users and if they were to be specified on the license. That is how he prefers it. I asked about not having anything listed on the Appendix N submittal and he said that it was section 9.8 of his procedure. This will be confirmed in the electronic mail request to him. I discussed how they were keeping gauges separate from the other two licensee's at the site. He said they have control of specific buildings and the material would be kept in those buildings. I will confirm this in the electronic mail.
