Meeting Purpose

- Discuss preliminary draft rule language regarding Long-Term Cooling (LTC) in the 10 CFR 50.46c proposed rule
 - Draft revised SOC is in ADAMS at Accession No. ML15135A178
- Afford an opportunity for stakeholders to provide oral feedback on preliminary draft rule language, which represents a possible change to the LTC provision in the 10 CFR 50.46c proposed rule.
 - Comment period ended on August 21, 2014



Meeting Purpose (cont'd)

- Staff will consider oral comments made in developing the final rule and guidance
 - NRC will not be providing, in the final rulemaking, written comment responses to any oral comments made at this meeting
- The NRC is not taking written public comments at this meeting



Rulemaking Status(cont'd)

Staff has conducted public meetings to facilitate development of draft final rule package

 - April 23, 2015 (ML15138A434)

 - June 4, 2015
- Draft Regulatory Guides:

Rulemaking Status(cont'd)

- Draft regulatory guide DG-1322, “Alternate Risk-Informed Approach for Addressing the Effects of Debris On Post-Accident Long-Term Core Cooling,” published for comment on April 20, 2015 (80 FR 21658)



Next Steps

- 75-day comment period for DG-1322 closes on July 6
- NRC will continue to address public comments
- ACRS subcommittee and full committee meetings tentatively scheduled for November and December 2015
- Develop final rule package
 - Due to the Commission in February 2016 (per SRM-COMSECY-13-0006)
