Dear Mr. Toelle:

This refers to your letter dated January 28, 2015 (ACO 15-0005), which contained a list of facility changes made to the American Centrifuge Lead Cascade Facility and the American Centrifuge Plant during Calendar Year 2014. The U.S. Nuclear Regulatory Commission (NRC) staff performed a preliminary review of the changes, and by letter dated March 3, 2015, provided a list of potentially safety-significant changes that were selected for further review. In our letter, we also requested the change evaluation package for each of those changes. By letters dated March 20, 2015 (ACO 15-0011 and ACO 15-0012), you provided the requested change evaluation packages.

We have completed our review of the selected changes. Based on our review of each change package, we have determined these to be changes for which adequate safety measures were in place and/or were administrative in nature. In addition, our review has determined that all of the reviewed facility changes were appropriately made in accordance with the requirements of Title 10 of the *Code of Federal Regulations* (10 CFR), Section 70.72, and that prior NRC approval of these changes was not required. We have no further questions at this time. The individual results from our review are documented in the enclosure. This completes our efforts on Technical Assignment Control No. L34302.
