Flooding Rulemaking

- Appendix G Endorsed by Sept 2015
- Staff completion of Flood hazard assessment and letter issuance by end of 2015
- MSA for flooding completed by December 2016
- NRC approval of changes if necessary by 2017
- Industry implementation of changes within 2 refueling cycles of rulemaking



Flooding 50.54 (f)

- Develop screening guidance for IA end of 2015
- NRC endorsement of IA guidance by June 2016
- Screening for Integrated Assessment completed by June of 2017.
- NRC approval of screening by December 2017
- IA completed 1 year after NRC approval of screening results



Seismic Rulemaking

- Appendix H
 - Appendix H endorsed by end of 2015
 - MSA for seismic completed for by end of 2016 for path 1 and 2 plants
 - Path 3 and 4 schedule to be determined
 - NRC approval of changes if necessary
- SPRA plants would complete the SPRA and determine necessary changes based on risk assessment
- Resolution of Group 2 and 3 SPRA plants timeline not in alignment with rulemaking
- Industry implementation of changes within 2 refueling cycles of rulemaking or completion of SPRA, whichever is later

Seismic 50.54 (f)

- High Frequency Assessments (HF)
 - EPRI issue HF report by July 2015
 - High Frequency report endorsed by August 2015
 - HF assessment completed by end of 2016
 - NRC review completed by end of 2017
- Spent Fuel Pool Assessment (SFP)
 - Spent Fuel Pool seismic assessment guidance endorsed by end of 2016
 - SFP assessment completed by end of 2017
 - NRC review completed by 2018
- SPRA completed by 2017 2020



PROPOSED RULEMAKING: MITIGATION OF BEYOND-DESIGN-BASIS EVENTS

- Challenges
 - Fast tracking complex technical development of NEI 12-06 Appendix H for seismic
 - Draft reg. guide DG-1301 Appendix A
 - Late additions to rule make it challenging to comment during the review period
