BAVOL: The Commission is being asked to act on a Memorandum and Order related to the appeal by Local 15, International Brotherhood of Electrical Workers, AFL-CIO, of the Atomic Safety and Licensing Board's decision in LBP-14-4 denying Local 15's petition to intervene and request for hearing.

The Commission has voted to approve a Memorandum and Order that directs the litigants to provide either (1) a joint stipulation that Local 15's appeal should be dismissed or (2) briefing on the question whether Local 15's appeal should be dismissed as moot and this proceeding terminated.
