Dear Mr. Paulson,

By letter dated July 24, 2014, Kennecott submitted a source material license application to the U.S. Nuclear Regulatory Commission (NRC) requesting a ten-year renewal of Source Material License SUA-1350. The facility is currently in standby and not operating. The Technical, Environmental, and Financial Rebaseline Reports supporting the license application request are publicly available in NRC's Agency-wide Documents Access and Management System (ADAMS) under Accession Number ML14251A113.

The staff is conducting a technical review of the application request. This Request for Additional Information (RAI) is a partial set of RAIs for the safety aspect of the Technical Report and other RAIs may be submitted at a later date. Enclosed are the NRC staff's partial Request for Additional Information which identifies the information needed for the continued review of your license application request. Enclosure 1 contains the partial set of RAIs for the Technical Report.

Please respond or propose a schedule for responding to this partial set of RAIs within 30 days. Kennecott should prepare a table identifying the RAI response(s) and where the information is located in the revised Technical and Environmental Reports. Kennecott is encouraged to contact me if clarification is required for any RAI.
