11 MR. HOYLE: Chairman Jackson and Commissioner Rogers,
12 we have one paper, as you mentioned, SECY-95-270. In this
13 paper the Commission is being asked to approve an order
14 which would grant the Georgia Power Company's petition for
15 review of an Atomic Safety Licensing Board's order
16 compelling Georgia Power to produce certain documents. The
17 Commission's order would grant the petition for review, find
18 that the documents in question are privileged and vacate the
19 Board's order. This order is being approved today by the
20 Chairman under delegated authority voted by the Commission
21 as authorized by NRC Reorganization Plan No. 1 of 1980. Her
22 decision was made after consultation with Commissioner
23 Rogers. Chairman Jackson has stated her approval of the
24 order and Commissioner Rogers has stated his agreement with
25 the order. Please affirm your votes.

2 COMMISSIONER ROGERS: Aye

3 MR. HOYLE: Thank you.

4 CHAIRMAN JACKSON: Is there anything else to come
5 before us today?

6 MR. HOYLE: I have nothing further.
