3 CHAIRMAN JACKSON: Good afternoon, ladies and
4 gentlemen. This is an affirmation session. We have two
5 items before us.

6 Before I ask the Secretary to lead us through the
7 items for affirmation, does Commissioner Rogers have any
8 opening comments he would like to make?

9 COMMISSIONER ROGERS: No, thank you.

10 CHAIRMAN JACKSON: If not, Mr. Secretary, you may
11 proceed.

12 SECRETARY HOYLE: Thank you, Chairman Jackson,
13 Commissioner Rogers.

14 The first of the two items is SECY 95-277, having
15 to do with the Sequoia Fuel Corporation case.

16 The Commission in this case is being asked to
17 approve an order that reverses, in part, the Atomic Safety
18 and Licensing Board's memo and order, LBP 9505 dated April
19 18, 1995.

20 The order would reverse that portion of the
21 Board's order which requires the Staff to obtain prior Board
22 approval before referring confidential information obtained
23 through discovery to staff investigatory or enforcement
24 offices.

25 After affirmation today, this order is being

1 issued as approved by the Chairman under delegated
2 authority, voted by the Commission, as authorized by the NRC
3 Reorganization Plan Number 1 of 1980. The December is being
4 made after consultation with Commissioner Rogers.

5 Chairman Jackson has stated her approval of the
6 order, as proposed in the paper. Commissioner Rogers has
7 also stated his agreement with the order.

8 Let me ask you to affirm your votes, please.

9 CHAIRMAN JACKSON: Aye.

10 COMMISSIONER ROGERS: Aye.

11 SECRETARY HOYLE: Thank you.

12 The second paper is SECY 95-285 regarding the case
13 of curators of the University of Missouri.

14 The Commission is being asked to issue a
15 memorandum and order which denies the August 31, 1995,
16 petition for reconsideration by the intervenors in the
17 University of Missouri case.

18 The memorandum and order being issued today is
19 approved by the Chairman under delegated authority voted by
20 the Commission, as authorized by the NRC Reorganization Plan
21 Number 1 of 1980.

22 The decision is being made after consultation with
23 Commissioner Rogers.

24 Chairman Jackson has stated her approval of the
25 memorandum and order, as proposed in the paper.

1 Commissioner Rogers has also stated his agreement with the
2 memorandum and order.

3 May I ask you to affirm your votes.

4 CHAIRMAN JACKSON: Aye.

5 COMMISSIONER ROGERS: Aye.

6 SECRETARY HOYLE: Thank you.

7 CHAIRMAN JACKSON: Thank you.
