3 CHAIRMAN JACKSON: Good morning, again. We now
4 moving into an affirmation session. We have one item to
5 come before us this morning. Before I ask the Acting
6 Secretary to lead us through the item for affirmation, I
7 would like to ask my fellow Commissioner if he has any
8 comments he would like to make.

9 COMMISSIONER ROGERS: No.

10 CHAIRMAN JACKSON: If not, Dr. Bates, you may
11 proceed.

12 MR. BATES: Thank you, Madame Chairman. The item
13 this morning is SECY-95-203 in the matter of the Curators of
14 the University of Missouri Licensee's Petition for
15 Reconsideration.

16 The Commission is being asked to act on an order
17 arising out of a request by the University of Missouri for
18 the Commission to reconsider and clarify its decision in
19 CLI-95-01 and CLI-95-08 that required the University's
20 emergency plan to include a "Site Area Emergency"
21 classification for certain accidents involving nuclear
22 materials.

23 The order being issued today is approved by the
24 Chairman, under delegated authority voted by the Commission
25 as authorized by the NRC Reorganization Plan No. 1 of 1980.

1 This decision was made after consultation with Commissioner
2 Rogers.

3 The order denies the petition and makes clear that
4 a "Site Area Emergency" comes into play only when fires or
5 accidents involving nuclear materials may lead to
6 significant exposures at the site boundary.

7 It also directs the University to require
8 evacuation of all persons except emergency personnel to a
9 point at least 150 meters from the Alpha Lab whenever an
10 "Alert" is declared as a result of a fire involving the
11 TRUMP-S materials.

12 Chairman Jackson has stated her approval of the
13 order. Commissioner Rogers has also stated his agreement
14 with the order. Will you affirm your votes?

15 COMMISSIONER ROGERS: Aye.

16 CHAIRMAN JACKSON: Yes.

17 MR. BATES: I might note that the second item that
18 we had listed in the public announcement for the meeting is
19 being postponed and will perhaps be re-held next week.

20 CHAIRMAN JACKSON: Is there anything else to come
21 before us today?

22 MR. BATES: I have nothing else.

23 CHAIRMAN JACKSON: If not, we stand adjourned.
