This is in reference to your letter dated March 18, 2015 requesting to amend Nuclear Regulatory Commission License No. 08-11182-01. In order to continue our review, we need the following additional information regarding your request for an amendment to add Dr. Ali Hasan Hadi Albayati as an authorized user.

1. In support of your request to authorize Dr. Ali Hasan Hadi Albayati for materials permitted under 10 CFR 35.100, 35.200, and 35.300, please provide the following:
 - a. For the requested authorization for 35.100 and 35.200, complete "**Part II-Preceptor Attestation**" of the attached NRC Form 313A (AUD), the preceptor should also complete and sign the second section at the bottom of Part II
