PURPOSE: The purpose of this meeting is to discuss the implementation of the two-phased approach to revise the U.S. Nuclear Regulatory Commission's (NRC) cost-benefit guidance documents, primarily NUREG/BR-0058 (Agencywide Documents Access and Management System Accession (ADAMS) Accession No. ML042820192), NUREG/BR-0184 (ADAMS Accession No. ML050190193), and NUREG-1409 (ADAMS Accession No. ML032230247) as directed by Staff Requirements Memorandum (SRM)-SECY-12-0110, "Consideration of Economic Consequences within the U.S. NRC's Regulatory Framework" (ADAMS Accession No. ML12173A478) and SECY-14-0002, "Plan for Updating the U.S. NRC's Cost-Benefit Guidance" (ADAMS Accession No. ML1327A519). performing cost-benefit analyses in support of regulatory, backfit, and environmental analyses.
