This letter refers to your letter dated July 1, 2014, (ML14190B310) requesting an extension to submit the Pickard Hall Decommissioning Plan. On August 28, 2014, the U.S. Nuclear Regulatory Commission (NRC) sent the licensee an acknowledgement letter (ML14241A650) stating the NRC had received the request. The NRC has continued to review licensee documentation associated with the request and had performed and documented a site visit on February 10, 2015, to gain additional information to support the request (ML15054A140).

On March 26, 2015, the NRC received documentation associated with the licensee's decommissioning plan of Pickard Hall (ML15106A640). As such, the need for an extension request has now been rendered mute and the NRC is voiding the requested licensing action.
