Specifically, you requested that the Commission amend its regulations concerning exemptions from licensing requirements to include illumination markers containing tritium. The petition was docketed as PRM-32-8, and the NRC published a notice of receipt and request for public comments in the *Federal Register* on July 11, 2013 (78 FR 41720), and posted on [www.regulations.gov](http://www.regulations.gov) under Docket ID NRC-2013-0078. The comment period closed on September 24, 2013. The NRC received one comment submission in response to the request for comments (ADAMS Accession No. ML15008A372).

The NRC has considered the petition, and the arguments raised therein, as well as the comment received in response to the petition. For the reasons stated in the enclosed *Federal Register* notice, your petition for rulemaking is being denied.

The NRC has concluded that your petition fails to demonstrate that a specific exemption is warranted and that the existing regulatory framework for self-luminous products is inappropriate.
