Dear Mr. Dacus:

The former Kewaunee Nuclear Power Station, which operated for more than 30 years, was purchased by Dominion in 2005 and shut down in 2012.

Dominion has appraised the value of the facility at \$10 million. Two private appraisers have estimated the value to be between \$455 and \$500 million.

Would the Nuclear Regulatory Agency have subject matter experts that appraise or review appraisals of shuttered plants to help determine the most accurate value?
