Dear Mr. Hosfeld:

Enclosed is Amendment No. 80 to your NRC Material License No. 21-01549-02 in accordance with your request.

Please note that significant changes to your license may appear in **bold** font, such as format changes resulting from requests you made and updates that we have implemented at this time.

**This amendment renews your license for a ten year term. Your license will not expire until June 30, 2025.**

**At this time, because you are not using Positron Emission Tomography (PET) materials permitted by 10 CFR 35.200 under this license, we have excluded authorization for PET materials from Subitem No. 6.B.**

**The changes made to your license in Amendment No. 79, which was acted upon while this renewal was pending, have been carried over into this amendment also.**

**Your letters dated December 30, 2014, and June 25, 2015, requested a change in the name on your license to reflect your affiliation with the University of Michigan (U of M), which apparently took place in June 2013.**

**It appears that this affiliation constituted a change in ownership and/or control. You will have to apply for and obtain NRC's written consent at this time.**

**In our telephone discussion on June 11, 2015, in which we discussed the request for additional information letter I faxed to you dated June 11, 2015, it was mutually agreed that you would respond to this matter separately.**

**We will consider the name change you requested for this license, resulting from the change in ownership/control, when we review your request for the change of ownership/control that you should submit now.**

Please review the enclosed document carefully and be sure that you understand all conditions.

The enclosed document contains sensitive security-related information.  
When separated from this cover letter this letter is uncontrolled.


