By letter dated February 24, 2015 (AC 15-004), you requested U.S. Nuclear Regulatory Commission (NRC) review and approval of the Security Plan for the Protection of Classified Matter at Centrus Energy Corp. (Centrus) Headquarters (Agencywide Documents Access and Management Systems (ADAMS) Accession Number ML15065A055). The NRC reviewed your submittal, and determined that additional information was needed. By letter dated April 7, 2015, we sent you a Request for Additional Information (RAI) (ADAMS Accession Number ML15091A713). By letter dated May 14, 2015 (AC 15-0006, (ADAMS Accession Number ML15146A175) you provided your responses to our April 7, 2015 request.

Our review of your responses to the May 14, 2015, RAI identified additional information that is needed before a final action can be taken. The additional information specified in the enclosure should be provided to us within 15 days from the date of this letter. Please reference Technical Assignment Control Number L34312 for this action in your response.
