The information that we do have comes from an Environmental Site Assessment prepared in 2000 by Arcadis Geraghty & Miller (attached). Grumman operated an area in Building 26 from 1964 to the mid 1990's for "radiation effects studies" in which various types of metals were tested with different types of radiation. Grumman had a radioactive license from the Department of Labor (license No 733-0291) which covered a Van der Graph generator and a Karmann neutron generator (which was in the basement). The Karmann generator contained a sealed radioactive source which would have been disposed of under DOL oversight when the license was terminated. The Van Der graph generator used no radioactive materials. If you have any factual information that a research reactor existed, we would appreciate receiving it. Jim H"
