AND ASSOCIATES, LLC REQUEST FOR WITHHOLDING INFORMATION  
FROM PUBLIC DISCLOSURE

Dear Mr. Karchon,

By your amendment request and affidavit dated May 5, 2015, executed by Megan Lang, you submitted "NRC Form 313", "Form 313 answers to 5-11", "Discussion of Changes", "Cammenga and Associates, LLC SS&D License # NR-0210-D-102-E", and "Cammenga & Associates, LLC E-License # 21-26460-03E", and requested that it be withheld from public disclosure pursuant to 10 CFR 2.390.

Your reasons for requesting our withholding of this information from public disclosure were that these documents contain proprietary information that contains (1) distinguishing aspects of a process, component or methods that would constitute a competitive economic advantage over other companies, (2) supporting data, including test data relative to process, component, structure/method, the application of which secures a competitive position for Camenga, including product optimization, (3) the use of this information would reduce competitors expenditure of resources or improve its competitive position in design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product, (4) the information includes Cammenga's private partnerships, collaboration, supply and customer base.

We have reviewed the documents in your amendment request and all of the supporting information in accordance with the requirements of 10 CFR 2.390 and have concluded the documents do not contain information that should be withheld from public disclosure and that contain proprietary, confidential commercial and/or financial information.

Accordingly, we have concluded that the information sought to be withheld from public disclosure does not meet the requirements of 10 CFR 2.390. Therefore, your request to withhold "NRC Form 313 "Form 313 answers to 5-11", "Discussion of Changes", "Cammenga and Associates, LLC SS&D License # NR-0210-D-102-E", and "Cammenga & Associates, LLC E-License # 21-26460-03E" from public disclosure is denied.
