#### **RADIOACTIVE MATERIAL USER PERMIT** (HUMAN USE)

A permit is hereby issued authorizing the individuals named herein to receive, acquire, and possess the radioactive materials listed below in the given quantities, and to use such radioactive materials for the purposes and at the places designated below. This permit is subject to all applicable rules and regulations of the Hospital, and, in particular, to the provisions of Title 10, Part 20, Code of Federal Regulations, Chapter 1, "Standards for Protection Against Radiation". Radioactive materials specified herein shall be used only on the Hospital premises and by, or under, the supervision of the named individuals.

Radioactive material for use in humans shall be acquired from a supplier who certifies the pharmaceutical quality and assay of such material. If radioactive materials are prepared within the Hospital for human use, the methods of establishing pharmaceutical quality shall be approved by a Subcommittee of the Radiation Safety Committee. All users requiring check, calibration and reference sources are authorized under 10 CFR 35.65 to possess same.
