On July 17, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security inspection at your Vogtle Electric Generating Plant, Units 1 and 2. On July 20, 2015, the inspection results were discussed with you and other members of your staff. The results of this inspection are documented in the enclosed inspection report (IR). The NRC inspector did not identify any findings or violations of more than minor significance.
