Category: This is a Category 1 meeting. The public is invited to observe this meeting and will have one or more opportunities to communicate with the NRC after the business portion of the meeting but before the meeting is adjourned.

Purpose: The purpose of this meeting is for NuScale to present the methodology to be used in place of the existing GALE computer code to estimate normal operation effluents. The presentation will justify the replacement methodology while demonstrating consistency with the mechanisms identified in NUREG-0017, "Calculation of Releases of Radioactive Materials in Gaseous and Liquid Effluents from Pressurized Water Reactors: PWR-GALE Code." Note that the Public portion of the meeting only covers the first 45 minutes to provide the public a general overview of NuScale's effluent release methodology. The NRC has determined, in accordance with Title 10 in the Code of Federal Regulations 2.390 that the information discussed during the closed portion of the meeting is proprietary in nature and therefore should be closed to the public.
