**High Energy Arcing Faults Phase 2**

On July 15, 2015, as a result of a full and open competitive solicitation, fixed-price contract number NRC-HQ-60-15-C-0004 was awarded to Kema PowerTest, LLC, in Chalfont, PA. This contract provides a testing facility that is accredited by the International Organization for Standardization and is capable of conducting high power electrical tests. The testing conducted provides more data that will help improve the NRC's understanding of the High Energy Arcing Faults phenomena. The period of performance is July 15, 2015, through July 14, 2016, with four 1-year options. The total price is \$646,520, inclusive of all options.

**Ergonomic Assessment Program**

On July 17, 2015, as a result of a competitive solicitation, firm fixed price/labor hour hybrid, task order number NRC-HQ-84-15-T-0001 was issued under General Services Administration Schedule GS-10F00248 to Ergoworks Consulting, LLC, in Gaithersburg, Maryland. This contract provides for personnel, management, administrative, and technical services to support the operation of the NRC Ergonomic Assessment Program. The period of performance is August 1, 2015, through July 31, 2016, with four 1-year options. The total cost ceiling is \$212,749, inclusive of all options.

**Issuance of Byron Final Supplemental Environmental Impact Statement**

On July 16, 2015, the staff issued the Final Supplement 54 to NUREG-1437, "Generic Environmental Impact Statement for License Renewal of Nuclear Plants, Regarding Byron Station, Units 1 and 2." The final supplemental environmental impact statement (FSEIS) represents the completion of the staff's environmental review of the license renewal application submitted by Exelon Generation Company, LLC. The FSEIS contains the staff's conclusion that the impacts would not preclude renewing the plant's license for an additional 20 years.
