Regulatory Guide 1.16, "Reporting of Operating Information - Appendix A Technical Specifications" Revision 2, a copy of which is enclosed, was issued in September 1974. It describes the information that is needed to permit assessment by the Commission of safety related activities during the operating life of facilities. The "Implementation" section of this Guide states that licensees should consider revisions to their technical specifications to assure submittal of the needed information. Accordingly, you are requested to submit, as soon as practical before December 1, 1974, a proposed change to your Technical Specifications, in the form of an application for license amendment, establishing reporting requirements in accordance with Guide 1.16; or provide justification for any departure from the Guide.
