ACHIEVABLE' FOR RADIOACTIVE MATERIAL IN LIGHT-WATER-COOLED

Dear Mr. Hiatt:

The U.S. Nuclear Regulatory Commission (NRC) received your correspondence dated July 6, 2015,<sup>1</sup> requesting that the NRC extend the public comment period on the advanced notice of proposed rulemaking (ANPR) for Part 50 of Title 10 of the *Code of Federal Regulations* (10 CFR), Appendix I (80 FR 25237; May 4, 2015). Specifically, you request a 60-day extension to the comment period.

The NRC has reviewed your request and approves a one-time, 30-day extension to the public comment period. This decision is based on the comments received from the Nuclear Energy Institute (NEI) in response to the 10 CFR Part 20 ANPR (79 FR 43284; July 25, 2014) on issues that are common to both the 10 CFR Part 20 and the 10 CFR Part 50, Appendix I, ANPRs and
