

Dear Sir:

Your letter of February 23, 1979 requested an extra \$400 in license fees be provided to support the licensing of the increase in the storage capacity of the spent fuel pool shared by Oconee Units 1 and 2.

Duke Power Company considers that the payment of a license fee for an identical unit to be not applicable in this instance. Title 10CFR 170, §170.22 states that "amendments that are duplicate of an amendment for a second essentially identical unit at the same site . . ." are Class I amendments. The amendment to increase the storage capacity of the spent fuel pool shared by Oconee Units 1, 2, deals solely with one modification. There is only one spent fuel pool being modified to increase its capacity. There is no "second essentially identical unit" for which the \$400 Class I license fee would be applicable. Through earlier discussions with the staff it has also been determined that the Class I license fee is not required for duplicate units just for the administrative costs associated with the issuance of license amendments for the identical units so long as the identical units are not affected by the license amendment. It was therefore concluded by Duke Power Company to provide only the \$12,300 license fee in the original submittal.


