
Dear Sir:

Pursuant to 10CFR 50, §50.90, the attached proposed amendment to the Oconee Nuclear Station Facility Operating License and revision to the Technical Specifications is submitted. This proposed change revises Specification 4.5.1, Emergency Core Cooling Systems by revising the surveillance requirements for valves LP-17, -18.

The justification for this change has been discussed with the ONRR Project Manager for Oconee and is briefly described in the Bases of this specification.

Pursuant to 10CFR 170, §170.22, this amendment request is deemed to consist of one Class III and two Class I license fees. Therefore, please find attached a check in the amount of \$4,800.


