


Dear Sir:

Please find attached proposed revisions to Oconee Nuclear Station Technical Specification 3.5 and the Bases of Technical Specification 4.5. These proposed changes are considered to be administrative in nature. Technical Specification 3.5 is being revised to change the format of Table 3.5.1-1 to the Standard Technical Specification format. The last paragraph of the Bases for Technical Specification 4.5 is being revised due to previous incorrect wording.


