SUMMARY

By letter dated July 14, 2015 (ADAMS Accession Number: ML15196A621), Westinghouse Electric Company, LLC, (certificate holder) requested renewal of Certificate of Compliance No. 9292 for the Model No. PATRIOT package. The certificate holder did not request any changes to the package design, operating procedures, acceptance tests, or maintenance program of the package. The certificate has been renewed for an additional five years.

EVALUATION

By letter dated July 14, 2015, Westinghouse Electric Company, LLC, requested renewal of Certificate of Compliance No. 9292, for the Model No. PATRIOT without changes to the package design, operating procedures, acceptance tests, and maintenance program of the package. The certificate holder has a NRC-approved quality assurance program (Docket No. 71-0708).

CONDITIONS

The following changes have been made to the Certificate:

Condition 1.b. was changed to Revision 7.

Condition No. 11 was revised to "Revision No. 6 of this certificate may be used until August 31, 2016."

Condition No. 13 was revised to "Expiration date: August 31, 2020."

The "REFERENCES" section was revised to include the date of the renewal request.

CONCLUSION

The certificate has been renewed for a five year term. These changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
