Gentlemen:

By letter dated September 9, 1988 Duke submitted Rev. 1 to Licensee Event Report (LER) 269/88-06 concerning the inadequate design analysis of the high pressure injection system in the ECOS sump recirculation mode. Within the LER, Duke committed to the following corrective actions:

1. Perform a review to verify operability of all ECOS valves which are required to be available to change position;
2. Revise Technical Specifications to reflect the results of the review of ECOS valves.

The review and related Technical Specification change are currently in preparation, Technical Specification changes will be submitted by February 28, 1988.
