

Response to Supplement 1 of Generic Letter 87-02  
on SQUG Resolution of USI A-46

My letter dated January 15, 1993 provided a response to the questions contained in Mr. L. A. Wiens' letter dated November 19, 1992. This letter is being provided to clarify my January 15, 1993 response based on a conference call on March 2, 1993 between Duke Power personnel and members of the NRC staff.

Oconee Nuclear Station hereby commits to implement both the SQUG commitments and the implementation guidance that are provided in the Generic Implementation Procedure, Revision 2 (GIP-2), as corrected on February 14, 1992 and as accepted by the NRC Staff in the SSER No. 2 dated May 22, 1992. As of this time, Oconee Nuclear Station has not identified any significant or programmatic deviations that require notification of the NRC. It is understood that, pursuant to Section 1.3 of GIP-2, any substantial deviations from the SQUG commitments must be justified to the NRC in writing prior to implementation. It is also understood that Section 1.3 of GIP-2 contains provisions for substituting clearly equivalent methods without prior notification of the NRC and for making significant or programmatic deviations from the GIP implementation guidance with prior notification of the NRC. In any case, deviations or substitutions that may be identified in the future will be handled according to the provisions of Section 1.3 of GIP-2.
