Ladies and Gentlemen:

In accordance with 10 CFR 52.99(a), Southern Nuclear Operating Company (SNC), as a Combined License (COL) holder under 10 CFR 52, hereby submits to the Nuclear Regulatory Commission (NRC) the current construction schedule information for completing the Inspections, Tests, Analyses, and Acceptance Criteria (ITAAC) Completion Packages associated with the Inspections, Tests, and Analyses (ITA) in the approved ITAAC for Vogtle Electric Generating Plant (VEGP) Units 3 and 4. This information is based upon integrated project construction schedule information that was provided to SNC by the Contractor.

Enclosure 1 to this letter is the ITAAC completion schedule for VEGP Unit 3, and Enclosure 2 is the ITAAC completion schedule for VEGP Unit 4. The enclosed ITAAC completion schedules serve to satisfy the 10 CFR 52.99(a) regulatory requirement for the NRC to receive an updated ITAAC completion schedule every six months. The previous ITAAC completion schedules for VEGP Units 3 and 4 were submitted to the NRC on February 9, 2015. Future ITAAC completion schedule updates will continue to be submitted to the NRC in accordance with the provisions of 10 CFR 52.99(a).

The enclosed schedules are dated July 7, 2015 and contain the most current information. Enclosure 3 serves as a Reader's Guide for understanding the construction information contained within each ITAAC completion schedule. The activity dates shown in the enclosed ITAAC schedules are determined by the Contractor as they relate to construction activities currently reflected in the VEGP 3 and 4 integrated project construction schedule owned by the Contractor. As is typical with a construction project, the schedule information is subject to change. Any changes to the project schedule will be reflected in SNC's future ITAAC completion schedule updates.

The construction schedule information contained within the Enclosures is considered proprietary to both Westinghouse Electric Company, LLC (Westinghouse) and Chicago Bridge & Iron (CB&I) Company, and was determined to be treated as such based on affidavits considered by the NRC in its letter to Westinghouse dated August 12, 2009 (ADAMS ML092240522).

Accordingly, it is respectfully requested that the enclosed VEGP Units 3 and 4 construction schedule information be withheld from public disclosure in accordance with 10 CFR 2.390. The project schedule information provided with this letter is proprietary in its entirety; thus, a non-proprietary version is not provided.
