
Dear Mr Gonzalez,

With reference to your letter dated 11-Aug-2015 regarding the license application request by Plus LLC, please note the following responses to each of the 3 points mentioned -

1. You asked for clarification whether the model numbers for the tritium sources are T6080-1, T6042-1, T6043-1 as specified in our response dated 23-July-2015 or are they X00/A, X00B and X00C as mentioned in our previous submission. We should have clarified in our letter dated 23-July-2015 that the model numbers mentioned in our previous submission are to be discarded since those are older and outdated numbers no longer used by mb-microtec. The current model numbers in use and indeed the model numbers used to identify the tritium sources in the watches currently being manufactured are T6080-1, T6042-1, T6043-1 as specified in our response dated 23-July-2015. We hope this is sufficient clarification for this particular issue. Kindly let us know if any further clarification is required on this question.
2. You asked for clarification on what you perceived as model numbers "43 MM" and "45 MM" taken from our previous correspondence dated 25-June-2015. We should have clarified that, from your response dated 30-June-2015, we could see that the information sent to you on 25-June-2015 had created a misunderstanding about model numbers, probably because of the way the information was presented. "43 MM" and "45 MM" were never meant to be model numbers. We should have been clearer in the vocabulary and template used while presenting you the requested information in our response dated 25-June-2015. To make amends for this and to eliminate your misunderstanding, we made a deliberate and conscious effort to present the information in a better format on 23-July-2015. Thus you can simply disregard the material dated 25-June-2015 and instead use the material dated 23-July-2015 that seems to have been interpreted correctly by you, i.e. 0200, 4200, 6250, etc. are indeed the model numbers. There are 53 models in total, subdivided among 12 groupings, as outlined on the first page of section 2 of that correspondence. If there still remains any confusion for this particular issue, do let us know and we will gladly provide further clarification.
3. You state that the location of the tritium sources are still not clear to you through any of the drawings and photographs submitted. We are confused by this point because we had believed we had submitted more detail than would have been necessary for a determination of the location of the tritium sources. You had invited us in your letter dated 30-June-2015 to meet you in your offices in Rockville, Maryland to discuss the questions in your request. At this point, we would like to accept the invitation for such a meeting so that we can understand what precisely you perceive as acceptable visual imagery that would help you determine the location of the tritium sources in each of the models.

Kindly propose a date/time as per your availability. Thank you for your patience and cooperation.
